Recommendation: THAT Council of the Corporation of the Town of Smiths Falls pass a Bylaw to award Contract 24-PW-011 for Milling of Asphalt, Grading, Hot Mix Paving and Miscellaneous Concrete & Rehabilitation to Thomas Cavanagh Construction Limited:

AND FURTHER THAT Council authorizes the Mayor and the Clerk to executive a contract agreement with Thomas Cavanagh Construction Limited for the amount of \$818,235.62 (excluding HST).

Purpose: The purpose of this report is to provide background on the tender process for the annual Milling of Asphalt, Grading, Hot Mix Paving and Miscellaneous Concrete & Rehabilitation (ACPM) capital project and to award the contract to the lowest qualifying bidder.

Background: Proposed works specified within the tender documents will result in the rehabilitation of roadways and asphalt surfaces, vertical adjustment of existing appurtenances (maintenance hole frames and covers, water valve boxes), replacement and/or installation of new concrete curbing and sidewalks and minor landscaping reinstatement. Locations, scope of work, and associated bid price from Thomas Cavanagh Construction Limited are listed below for reference;

Terms of the contract require that all works commence no later than July 22, 2024 and be completed on or before September 30, 2024.

The public tender closed on June 27, 2024. The Town received a total of two (2) tender submissions.

NOTE: Town staff have completed arithmetic checks on all bids. No discrepancies were noted.

The tender prices are as follows;

Town staff have reviewed the two (2) tender submissions for accuracy and completeness and were otherwise found to be compliant with the Town's procurement bylaw.

Analysis and Options: Thomas Cavanagh Construction Limited had the lowest bid submission. The following options are presented for consideration;

Option 1 (recommended) – Award the contract to Thomas Cavanagh Construction Limited as they were the lowest tender and have the ability and resources to complete the works.

Option 2 (not recommended) – Do not award the contract to the lowest bid and consider the other higher bid submissions.

Budget/Financial Implications: There is a total of \$840,000 approved in the 2024 Capital budget to complete the works. Table 2 below outlines the departmental funding sources allocated to accommodate this work.

The sidewalk work from the Old Slys fixed bridge to the entrance to Lower Reach Park was requested after the 2024 Capital Budget was approved. This addition accounts for \$44,876.12 (with net HST) in additional costs, however staff recommend for this addition to be completed under the 2024 program. It is recommended that the project overage of \$37,512.69 (with net HST) be funded from Capital reserves.
